Knowing this man was not eating, Michael Bryant, volunteer, asked if he could take him a box of our donated protein drinks. This small gesture spoke volumes of love and caring to the gentleman. He cried!

Each of our volunteers may be donating their time and talents but their love and compassion is the spirit of JFMC. This past month another young patient with extreme hypertension (221/147) was admitted to the hospital five times. The patient was frustrated and depressed, feeling no one cared. Doctor Opila intervened and connected the patient to Conemaugh's Internal Medicine Clinic. Dr. Aldergash and Dr. Trostle listened, treated and helped our patient. People do care and I am proud to be part of the Johnstown Free Medical Clinic.

Special Thanks to United Way & Easter Seals

Last June we added several new medical services including free hearing screenings. The screenings started slow, but appointments have steadily increased. Appointments are scheduled one day a month here at the clinic. All screenings are conducted by a certified audiologist from the Easter Seals through the generous support of the United Way of Laurel Highlands. In just three months the Easter Seals has conducted free screenings on 15 of our patients finding six who required follow up which they are receiving.
